The report sets out what work the sub group consider is necessary immediately and in the mid term and in the long term. It was agreed by all Cllrs present to adopt the proposals contained in the report. The Clerk reported that he had received a phone call from Mrs Grindey from Waterpark Road expressing some concern about the willow trees situated by the pond area. The Clerk said he had sought a second opinion from Lee Bassett who felt that some work was necessary on the trees located by the pond. Cllr Stubbs referred to the boundary hedge on the school side of the area and said it needed to be properly laid by a hedge layer. The Clerk was asked to obtain a price from Lee Basset for the immediate work required and to get a price from a hedge layer for the hedge. | | P 06/3 | Proposal for Sub Group to Oversee Play Equipment Maintenance & Replacement | The Chairman referred to paper written by Cllr Bryan and circulated by the Clerk on 1/10/07. There is an opportunity to apply for funding from the Derbyshire Community Foundation. The funding is not available to Parish Councils and it would be necessary to set a group separate from the PC which would need a committee, constitution and bank account. The proposal is for the Parish Council to agree to the setting up of the group to apply for funding for the skate park element of the proposed new playground. This would include the setting up of a high interest bank account and transfer of money raised by the Scarecrow competition and other village fundraising events from this financial year from the PC's Playground Fund to the bank account set up by the new group. Any funds raised by the new group would go to this account and any funds raised on behalf of the PC would go into the PC's Playground Fund. Following discussion, although in supportive in principle, a number of concerns were raised, including handing over monies raised for the Playground Fund in the Parish Council's name to another organisation. Also concerns regarding which part of the new playground would be cut in the event of a shortfall in funding and questions over responsibilities and accountabilities between the PC and the new group. The Chairman suggested that because Cllr Bryan and several other Cllrs were unable to attend the meeting a further meeting be convened on 16/10/07 to specifically discuss this item. All Cllrs present agreed to this course of action. Post meeting note: The meeting took place on 16/10/07 with all eight Cllrs attending. Cllr Bryan said it was not now necessary to transfer monies from the PC's account because of new fund raising monies promised to the new group. Following | | |

| | | | discussion it was proposed that the new group will be responsible for separately raising funds, ordering and paying for the skate park equipment within the overall plan for new playground equipment. On completion of the skate park element the ownership and maintenance responsibility will transfer to the Parish Council. Two Parish Councillors – Cllrs Bryan and Jarville will be on the group's committee. An amended constitution for the group will be prepared by Cllr Bryan and circulated to reflect the proposal set out above.
