The Inspector advised that in its current form the Local Plan would not be found sound. In light of the outcomes of the Examination in Public a resolution to withdraw the Local Plan was made on 2 October 2014 by a decision of the authority's full Council. The resolution to withdraw was made under the provision of Section 22(1) of the Planning and Compulsory Purchase Act 2004 (as amended) which provides for a local planning authority to withdraw a local development document at any time up to its adoption. The Council has issued a Notice of Withdrawal [PDF 0.06MB] in accordance with Regulation.
