Representatives from Gladman Developments asked Councillors if they wished, if their planning application on Babbs Lane is approved, take over the land which has been earmarked for a doctor's surgery and submit details of any projects they would like funding to be allocated for within a Section 106 Agreement. Councillors thanked the representatives for attending the meeting. The offer was discussed and it was felt that as the Parish Council object to the current planning applications it would not be proper to become involved in negotiating a Section 106 Agreement with the company until such time as the application has been determined. It was RESOLVED to inform Gladmans accordingly.

05.02.17 APPROVE MINUTES OF THE MEETING OF THE PARISH COUNCIL HELD ON 3RD JANUARY 2017

The minutes of the Meeting of the Parish Council held on 3rd January 2017 were approved and signed by the Chair after it was noted that Cllr Bull had sent his apologies.
