Re: Doveridge Neighbourhood Plan
Town and Country Planning Act 1990 Act Schedule 4B para 12 (11 &12)

I am writing to you as the Qualifying Body to inform you that Derbyshire Dales District Council resolved on 12th April 2018 that the draft Doveridge Neighbourhood Plan, as amended in line with the Examiner's recommendations, satisfies the basic conditions and meets the provision made under sections 38A and 38B of the 2004 Act. The draft Doveridge Neighbourhood Plan will now proceed to a referendum on 14th June 2018.
